Child abuser gets 28-year term

Man tied to East Bay molestation and pornography net

HAYWARD — One of four men linked to an East Bay child-molestation and pornography network was sentenced Friday to 28 years in state prison.

Christopher Lawrence of Hayward was sentenced by Superior Court Judge Ming Chin on 11 counts of lewd and lascivious acts against four boys. He received the maximum sentence under the terms of a plea bargain.

Lawrence appeared in court Friday morning with two co-defendants, Jonathan Tampico, 39, of Livermore, and Robert Turner, 37, of Backed to

Turner is a former teacher at Las Lomas High School, Walnut Creek. Tampico is a former engineer in Lawrence Livermore Laboratory's "Star Wars" program. Their sentencing was postponed until April 20 at the request of defense attorneys.

A fourth man convicted in the child-molestation case, David M. Simons, 38, of Livermore, was sentenced in February to 16 years in prison after pleading guilty to molesting three boys, two of them from Livermore.

Authorities believe all four are members of the North American Man-Boy Love Association, an organization that advocates the rights of adults to have sex with children.

Lawrence had pleaded guilty to performing sexual acts with three boys, ages 9, 7 and 5, who lived in the same Hayward apartment building as Lawrence. He also admitted molesting a 10-year-old after becoming his "Big Brother" in June 1984.

"The defendant went to great pains to establish a position of trust and confidence with the mothers of these children," Chin said Friday in giving Lawrence the maximum sentence.

The Big Brothers organization terminated Lawrence in August 1986 after Lawrence moved to Pittsburg and his roommate was investigated on charges of child molestation, prosecutors said.

Chin said Lawrence showed boys pornographic videos to persuade them that sexual acts were proper and permissible.

Tampico faces the least amount of prison time — three to six years — after pleading guilty to one count of molesting a Livermore boy, 12.

But presentencing documents filed by Deputy District Attorney Kenneth Burr said Tampico was heavily involved in child pornography and processed photographs that Turner and Lawrence took of three Hayward boys they were accused of molesting over the course of at least one year.

advocates plead guilty to charges

HAYWARD — Four members of a group that seeks to legalize sex between adults and minors have pleaded guilty to child-molestation charges, closing a chapter in what one attorney called "a very painful case."

The men, including a Wahud Creek schoolteacher and a former Lawrence Livermore Laboratory employee, entered their new pleas Thursday in Hayward Municipal Court in exchange for reduced sentences. They had previously pleaded innocent.

Investigators said the men belong to the North American Man-Boy Love Association, an organization of pedophiles that supports the "rights" of adults to have sex with children.

The molestations took place in Livermore and Hayward.

One of the men, Robert Turner, has admitted his involvement in the organization. Turner, 37, of Berkeley, is a teacher at Las Lomas High School, Walnut Creek.

He was charged with lewd and lascivious acts with three boys, ages 5, 7 and 9; conspiracy to use minors for the distribution of obscene material, and conspiracy to exploit children. Prosecutors agreed to drop 20 of the 27 charges against him in exchange for the guilty pleas.

Jonathan Tampico, 39, of Livermore, pleaded guilty to molesting one boy, beginning when he was 10 years old. Tampico, a former Lawrence Livermore Laboratory employee, was arrested in May in Thailand, where he fled to escape prosecution, according to Livermore police.

Prosecutors linked Tampico and Turner to two men who allegedly set up a foster bome for children in Bangkok and had sex with the children.

In addition, Christopher Lawrence, 29, of Hayward pleaded guilty to four counts of child molestation. He was charged with molesting the same three boys whom Turner was charged with molesting.

David Simmons, 30, of Livermore, in jail on a previous child-molestation conviction, also pleaded guilty to molesting three boys.

Bruce Nickerson, Turner's attorney, said that a plea agreement was reached to reduce the sentences and to prevent the boys from having to testify.

"It's a very painful case for a lot of people," Nickerson said, "It's very distressing, I anguish for the clients. I anguish for the victims."

Turner, Tampico and Lawrence are to be sentenced March 2 in Hayward Municipal Court. Simmons faces sentencing Feb. 9. Conviction on a child-molestation charge carries a minimum sentence of three years.

Turner has been on compulsory leave without pay since his arrest last spring, said Bran Yaich, an assistant superintendent in the Walhut Creek school district. Once he is sentenced, his teaching credential will be taken away, Yaich said.

Turner was not charged with molesting his students.

Turner, a lifelong Bay Area resident, was a geologist before he became a teacher. He once delivered a speech for the North American Man-Boy Love Association, criticizing police, the news media and social workers for conducting a "witch hunt" against adults who show "the slightest attraction toward children."

He added in his speech, "Children can consent to sex and they can enjoy it immensely."
