MEMORANDUM OF DECISION

IN THE MATTER OF CLYDE H. MEANS

The Regional Review Committee, having reviewed matters related to the registration of Clyde H. Means hereby affirms the decision denying Mr. Means's registration in the Boy Scouts of America. We find that this action is appropriate, supported by the record before it and fully consistent with BSA standards of leadership.

Procedure dictates that, should an appeal be desired, a written request for appeal be directed to the National Council to: Chief Scout Executive, Boy Scouts of America, [REDACTED] [REDACTED] Irving, Texas 75015-2079. Application for a national review must be made in writing within thirty (30) days of receipt of this Memorandum and should explain why the applicant believes this decision to be in error.

MEMO TO FILE - by Richard Parker

3:00 p.m. - I had a long conversation with Mr. Means. Mr. Means was demanding a hearing. I advised him that we conduct a review and only the review committee could determine whether or not a hearing was necessary and, if the hearing were held, indeed he would have a chance to appear.

He was upset that we were operating outside the law. I advised him that we were not acting for the law; we were simply addressing an issue of membership in the Boy Scouts of America and we made no judgment of innocence or guilt. Local legal authorities would have to do that, should that be the case.

He repeated several times that Mr. Brundage had promised him a hearing. I suspect that there was confusion in the conversation with the words "review" and "hearing".

Mr. Means asked for my suggestions and I told him to feel free to send his side of the story in writing to us and feel free to have any associates who wish to comment send their comments to the review committee in writing.

He asked if there was an additional review step. I told him if he did not agree with the region's decision, he could appeal to the National Council, BSA.

1. Mr. Means explained to me that he has served nine years as a volunteer in Scouting.
2. Mr. Means explained to me that he had an incident in October whereby he ran out of his medication and threw a plastic bottle at [REDACTED], and hit his [REDACTED] in the face. Mr. Means takes 900 mg of Lithium per day.
3. Court found out and a "closed" hearing was held. The court ruled there was "excessive parent discipline." (300A)
4. He kept asking me who turned him in. This is his big issue. Means said his [REDACTED] school principal was told (at the hearing) not to discuss the case with anyone. Claims this principal was responsible for all this.
5. I told him we would get back to him.


