

# Travis child molester: • 15 years at hard labor

A Travis Air Force Base sergeant who admitted to sexually molesting 13 boys was dishonorably dishcharged Friday and sentenced to 15 years of hard labor.

Sgt. Curtis H. Knarich, 24, was sentenced after a six-member court-martial panel reviewed evidence -- including a 17-page rich—of sodomy and commission of other indecent acts against boys between the ages of 12 and 16.

Knarich entered guilty pleas to all 30 charges filed against him in accordance with a pretrial settlement that included a maximum sentence "cap" of 15 years. tiated by Patrick Claney, Knarich's attorney, and the Air Force, according to Maj. Mike Cox, public information officer for Travis Air Force Base.

The court-martial panel was intentionally not advised of the sentence provision of the settlement, Cox said, and recommended Knarich be sentenced to



## Travis Man Suspected of Illicit Sex

Sergeant Investigated for Making Advances at Children

A Travis Air Force Base sergeant is under investigation in connection with criminal sexual acts with minors, a spokesman for the base reported Friday.

As a result of an Air Force Office of Special Investigation inquiry, the 24-year-old suspect is in the custody of military police.

Curtis H. Knarich, who was assigned to the operating room at David Grant Medical Center, is suspected of one charge of sodomy and indecent acts with minors.

According to Lt. Pat Louis, deputy public information office at Travis, the sergeant is suspected of making sexual advances and taking photographs of children in sexual attuations.

More than one youngster was

believed involved, Lt. Louis said, but the exact number of victims is still to be determined.

Knarich was placed in custody July 3, she said.

A pretrial confinement hear-

ing is pending to determine if the suspect should continue to be incarcerated. An investigation will consider evidence to determine whether a general court martial is warranted.
