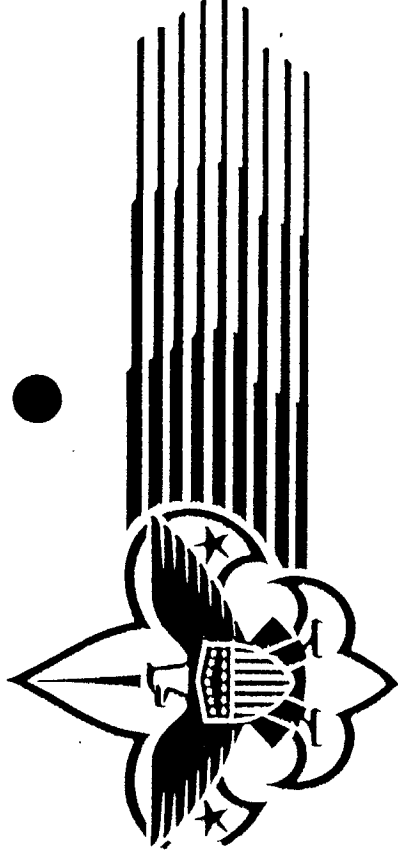

I have enclosed our records regarding the membership suspension of Gail Fisher who was registered as an Assistant Scoutmaster in Troop 1 and Troop 31 in the San Mateo County Council (#20).


I was contacted by the San Mateo Police Department and told that a complaint had been made regarding abuse by Mr. Fisher approximately 17 years ago. Apparently, when confronted by the police Mr. Fisher admitted to fondling a youth but he did not consider it to be child abuse.

I met with Mr. Fisher on May 24, 1990, and delivered our standard letter of suspension. He indicated at that time that he felt that what he did 17 years ago was not child abuse. I told him that if he felt that way, he could appeal the decision in the manner outlined.

By all indications, Mr. Fisher has not been active in either of these units for some time. Both units stated that they continued to register him out of courtesy, but that he had not been involved or active.

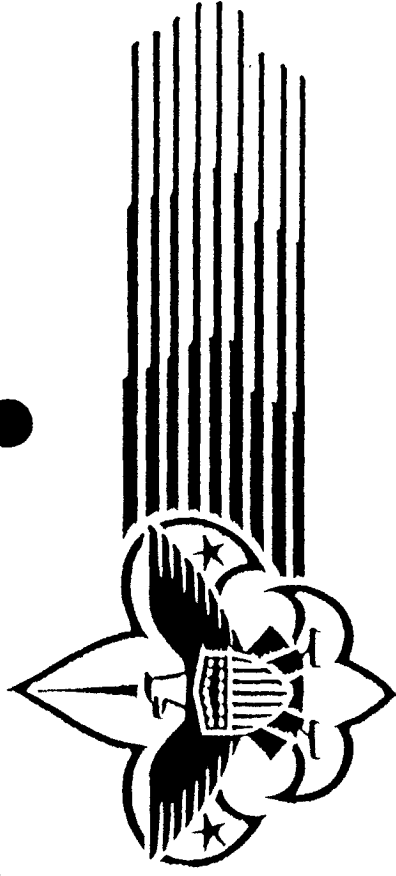

Dear Mr. Fisher:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are, therefore, compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.
