Thank you for sending me the Confidential Record Sheets for Charles "Jim" Dollar, Hank A. Jones and David P. Peak. This information is most helpful to us in identifying these individuals should they try to register at some other location with the Boy Scouts of America.

We would like more information concerning these items, and any you can give us would be most helpful in completing our file to make certain that we have all the necessary information for refusal.

If you can give me any specific information for Charles Dollar, I certainly think that the fact that he was a registered sex offender in 1973 would give us cause to refuse registration forever. We would like to, however, have more information on his conviction if at all possible through court records, newspaper clippings or other information.

The information on Hank Jones is very weak in that he was arrested for allegedly molesting [REDACTED]. Has there been a trial or conviction, was this a recent incident, or did this happen quite sometime ago?

We would look forward to having more information so that we may complete our file and justify our refusal of registration.

We would also like to know whether the charges that were pressed by the F.B.I. against David Peak were ever completed. Was there a trial and was a conviction secured?

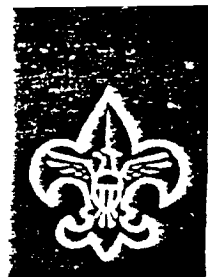
