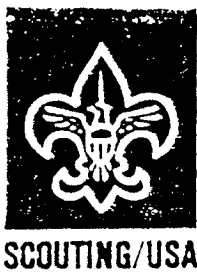

We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the Boy Scouts of America seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me, explaining your version of the facts supporting your claim that your registration as a Boy Scouts of America member should be granted.

MEMORANDUM

TO: Richard B. Frans

On December 27, 1987, Deputy Sheriff Sylvia at the Child Abuse Building at [REDACTED] in Whittier, California notified us of a Mr. Howard Day, registered with the Los Angeles Area Council as a MC of Pack and Troop #72 in Frontier District.

Mr. Howard Day admitted to sexually abusing [REDACTED] [REDACTED] now age nine and twelve, five years ago.

Mr. Day is now currently under investigation. His leader number is #023828 and resides at [REDACTED] [REDACTED] in the city of Cerritos, California and his telephone number is [REDACTED].

I completed and hand delivered a letter of discharge, signed by Mr. Ed Jacobs, to Mr. Day on January 4, 1988 at 5:00 p.m. with Mr. Ron Briggs, Varsity Scout chair, serving as a witness.

Both Mr. Parker and the District Chairman were notified.

Notification to the head of Administration at the National office has yet to be done.

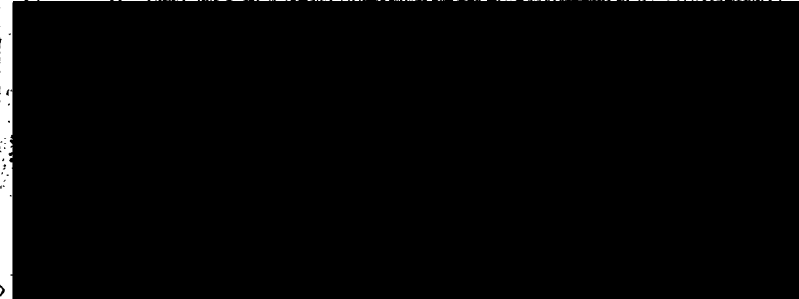

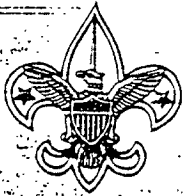
