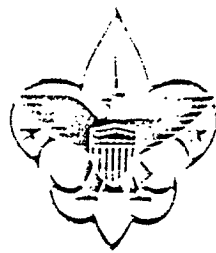

A check of our records indicated a Keith Meyer already on our file. This individual was placed on the file in July 1986 from the state of California. At that time, he was living in Bellflower, California which is in the Long Beach Area Council. He had been convicted for child molestation.

The birth date is the same as on your form and his middle initial given to us at that time was D, although we did not have his middle name.

You may wish to tell the legal authorities about this, since they may be able to have more evidence for keeping him in jail for longer periods of time.

Dear Mr. Meyer

After careful review of recent developments concerning your conduct, we have decided that your registration with the Boy Scouts of America should be denied now and in the future. We are, therefore, compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is concern that an individual may not meet the high standards of membership which the BSA seeks.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted. The procedures for a review of this decision are attached.

The following information is provided should you desire a review by the Northeast Region, BSA, of the decision to deny your registration.

1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to Northeast Region, BSA, BSA, P. O. Box 350, Dayton, New Jersey 08810. In your request, you must include your version of what occurred in support of your claim that registration should not be denied.
2. Upon the receipt of your written request, a committee will be appointed to review the situation.
3. If the regional review committee determines that a review hearing is necessary, the committee will advise you whether or not you may attend. In some instances, no useful purpose would be served by having the applicant present. The hearing is not adversarial in nature and neither the committee nor you, if you attend, will be represented by legal counsel. If you wish, in the event you attend, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you are dissatisfied with the decision of a regional review, you may request a further review by the National Council. The decision of the National Council will be final.

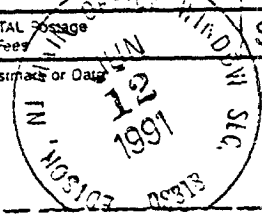

As per our conversation this date regarding Keith Dale Meyer, this letter is to inform you of actions to date involving this individual.

I am a Sex Crimes Investigator with The Pennsylvania State Police, currently assigned to Troop M, Bethlehem, Lehigh County PA. On 03/06/91, I was assigned to investigate an allegation of child sexual abuse with Mr Meyer being the suspect. The victim was a 12-year-old male child. My investigation provided sufficient evidence to prosecute Mr Meyer for Rape, Statutory Rape, Involuntary Deviate Sexual Intercourse, Indecent Assault and Corruption of Minors. I am in the process of preparing criminal complaints and obtaining warrants for Mr Meyer on these charges. Since he is presently incarcerated in New Jersey, the warrants will be served upon his return to The Commonwealth of Pennsylvania.

Mr Meyer was arrested by investigators from the Middlesex County (NJ) Prosecutor's Office on 05/15/91 on charges of Aggravated Sexual Assault and Corruption of Minors. These charges resulted from an investigation by that agency into allegations involving Mr Meyer and the same 12-year-old male child. Mr Meyer is now incarcerated in Middlesex County Prison in lieu of \$100,000 bail on those charges.

During the course of my investigation, I learned that Mr Meyer may be registered with your council as an Adult Scouter. As a Scoutmaster of twenty years, I felt obligated to notify you of Mr Meyer's arrest on child sexual abuse charges involving young boys.

I must emphasize that, at this time, Mr Meyer has been arrested and charged - not convicted.

Federal law prohibits me from divulging any previous record of arrest, if such records exists. I am enclosing, however, a form that you may fill out and submit, that will give you any existing criminal arrest record.

I hope that this letter is of service to you in maintaining the integrity that we rightfully expect of The BSA.

Dear Carlos:

Thank you for your letter of October 9th concerning Mr. Keith Meyer. This individual lived in Bellflower, California, and has been indicted for child molestation. We have not yet received a final conviction and sentencing, so we do not know whether he skipped out of the state before a trial or not; we are checking with the Long Beach Council to determine the outcome of the legal action. I certainly would be very careful and not register him for any reason.

As I have indicated, we are setting up a file so that we will make certain that he does not get registered wherever he may move. I am sure this is the same individual as the one that was reported by the Long Beach Area Council. It is necessary to report to the Police Departments in California whenever you move if you are a convicted sex offender. That of course is not necessary in New Jersey but maybe we are lucky that he did, so that we now know where he is living.

Thanks for your help in protecting the youth of America.

I have been advised that a Mr. Keith Meyer has moved into our Council area.



ON MAY 23, 1991, JOSEPH GONNELLA, REGISTERAR OF THE BOY SCOUTS OF AMERICA COUNCIL INFORMING JOE OF A CONVERSATION HE HAD WITH DETECTIVE POWELL OF THE PENNSYLVANIA STATE POLICE WITH INFORMATION ABOUT A MR. KEITH DALE MEYER, BORN 1-1-50 AND POSSIBLY REGISTERED IN SAYREVILLE, NJ AS A SCOUTING LEADER. MR. CHASE GAVE JOE, DETECTIVE POWELL'S PHONE NUMBER.

I WAS OUT ON A VACATION DAY ON MAY 23 AND UPON RECEIVING THE NOTE FROM MR. GONNELLA ON MAY 24, I INSTRUCTED OUR COUNCIL REGISTRAR AND JOSEPH GONNELLA TO CHECK THE REGISTRATION ROSTERS OF ALL UNITS IN THE SAYREVILLE, PARLIN AND SOUTH AMBOY AREAS FOR MR. MEYER. THEY DISCOVERED A MR. KEITH MEYER WAS REGISTERED IN TROOP 97, RARITAN 347 DISTRICT, SAYREVILLE, NJ AS AN ASSISTANT SCOUT MASTER. I CALLED THE PA STATE POLICE PHONE # GIVEN ON FRIDAY AFTERNOON AND TOLD THE DISPATCHER MY NAME AND PHONE # TO GIVE TO DETECTIVE POWELL AS SOON AS POSSIBLE.

AFTER ATTEMPTING TO CALL DETECTIVE POWELL ON MAY 28, [AGAIN NOT AVAILABLE - LEFT MESSAGE]. I CALLED LARRY HOUGHTALING OF THE REGIONAL OFFICE TO INFORM HIM OF THE SITUATION. LARRY SAID HE WOULD ATTEMPT TO CALL MR. CHASE AND GATHER WHAT INFORMATION HE COULD FROM THE BOY SCOUT COUNCIL. DETECTIVE POWELL FINALLY REACHED ME ON THE 28TH AND INFORMED ME THAT MR. MEYER WAS ARRESTED IN MIDDLESEX COUNTY ON CHARGES OF AGGRAVATED SEXUAL ASSAULT AND WAS CURRENTLY IN COUNTY PRISON PENDING BAIL. DETECTIVE POWELL INDICATED THAT SIMILAR CHARGES WOULD BE SERVED ON MR. MEYER UPON HIS RETURN TO PENNSYLVANIA. IN DISCUSSIONS WITH [REDACTED] DETECTIVE POWELL DISCOVERED THAT MR. MEYER HAD CLAIMED TO BE A SCOUT LEADER AND BECAUSE OF THIS FACT, HE FELT IT IMPORTANT TO FORWARD THE INFORMATION AS SOON AS POSSIBLE.

DUE TO MY FATHER'S SURGERY, I TOOK A PERSONAL DAY ON MAY 29TH AND UPON RETURN ON MAY 30TH, I DISCUSSED THIS SITUATION WITH MR. HOUGHTALING, WHO INDICATED THAT WE SHOULD PROCEED WITH A MEETING TO VERIFY THE PROCEDURE FOR MAINTAINING STANDARDS OF MEMBERSHIP IN THE BOY SCOUTS OF AMERICA. WE SET UP AN APPOINTMENT ON MAY 31ST - 10 A.M.. AT THIS MEETING, WE DISCUSSED AND REVIEWED THE 1991 REVISION OF PUBLICATION 28-105A. COUNCIL PRESIDENT, MR. CHRIS KJELOSEN, WAS CALLED [I LEFT A MESSAGE] AND RETURNED MY CALL AROUND NOON THAT DAY. I FAXED PAGE 21 AND 22 OF THE PROCEDURES BOOKLET TO CHRIS TO TYPE AND SIGN DENYING MEMBERSHIP. THE LETTERS WOULD BE PICKED UP ON MONDAY AND MAILED CERTIFIED.

I NOTICED SOMETIME ON MONDAY JUNE 3 THAT TROOP 97 HAD RENEWED ITS CHARTER AND I THEN LOOKED AT THE CHARTER RENEWAL PAPERS. MR. MEYER HAD BEEN DELETED AS A LEADER BY THE UNIT IN ITS RENEWAL PROCESS. I ALSO NOTICED A CHANGE OF ADDRESS FROM THE 1991 ROSTER. I CALLED MR. HOUGHTALING AND ASKED WHAT BEARING THIS MIGHT HAVE. HE SAID HE WOULD CHECK WITH MR. PAUL ERNST AND GET BACK TO ME. MR. HOUGHTALING CALLED BACK THE NEXT DAY AND GAVE ME A SUBSTITUTE PARAGRAPH FOR THE FIRST PARAGRAPH OF APPENDIX 3, PAGE 21 OF THE PROCEDURES BOOKLET. I INFORMED HIM MR. KJELOSEN WOULD BE OUT OF TOWN UNTIL MONDAY, JUNE 10TH. I ALSO INFORMED HIM OF THE RECEIPT OF THE LETTER FROM DETECTIVE POWELL OUTLINING THE INFORMATION THAT HE COULD LEGALLY GIVE ABOUT THE CHARGES PENDING. MR. HOUGHTALING AND I AGREED THAT BECAUSE OF HIS INCARCERATION AND REMOVAL FROM TROOP 97'S CHARTER, THE NEW LETTER COULD WAIT FOR CHRIS KJELOSEN'S SIGNATURE ON OR ABOUT JUNE 10TH.

I SPOKE TO MR. KJELOSEN ON MONDAY JUNE 10 AND INFORMED HIM OF THE NEW INFORMATION. MR. KJELOSEN SIGNED THE LETTER OF DENIAL AND IT WAS MAILED CERTIFIED MAIL ON JUNE 12, 1991.

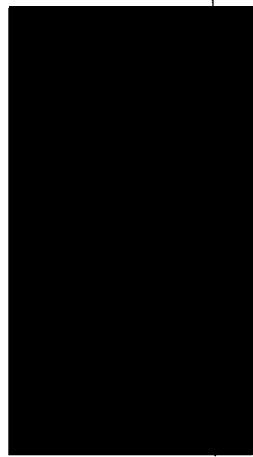
