We recently received information by phone from a lady who would not identify herself. She indicated that the above named individual had molested [REDACTED] in 1983. She indicated that he had plead no contest and was given a probationary sentence.

We find that this individual was registered in your council as a Member of the Committee in Troop S1201, and as an Assistant Webelos Leader in Pack C4201. He is in a lapsed status in both of these units as of the time we checked our files.

[REDACTED] We would like more information concerning this individual since he should be placed on the Confidential file, if the information is correct. It is indicated that the arrest took place in the Orange County Juvenile Court.

If you have any further questions, please do not hesitate to contact us. I am enclosing a Confidential Record Sheet which I would like to have completed with as much information as you have available.

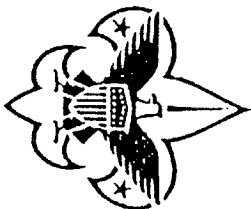

This morning I answered Public Relations' phone and a woman asked if she could talk without giving her name. She said she had information she felt we needed to know and wanted to be assured that the "source" would remain confidential.

OB 11-56
Kirk Immel, [redacted] was arrested in September of 1983 for molesting [redacted] (child was five-years-old). She has heard that he is now with BSA in the San Diego area.

The child, [redacted] was placed in the [redacted] Home for 18 months. The attorney who represented the child was Harold LaFlamme from the Los Angeles, Santa Ana area.

A record of this arrest is in Orange County Juvenile Court. Kirk Immel pleaded nolo contendere.

The caller said that [redacted] received counseling. Her concern now is that if Kirk Immel is associated in any way with BSA [redacted] will be 12-years-old in June), other children may be harmed.
